INVESTMENT OBJECTIVE AND STRATEGY

The Fund, operating as a fund-of-funds, seeks to achieve for its Participants capital appreciation and income by investing in a diversified portfolio of global fixed income collective investment schemes which integrate environmental, social, and governance criteria in its investment process, including the incorporation of sustainability goals and facilitation of flow of funds towards green economic activities, climate change mitigation and adaptation projects, and other positive environmental and social impact initiatives. The Fund aims to outperform its benchmark which is the Bloomberg Barclays Global Aggregate Bond Index (Unhedged).

CLIENT SUITABILITY

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

Market/Price Risk:



OUTLOOK AND STRATEGY

Market Review. Global fixed-income markets returned positive for the month amid easing inflationary pressures and expectations of a slower pace of interest rate hikes. Headline inflation in US and Eurozone softened, driven by declining energy prices. Sentiment also improved as China lifted their zero-COVID policy and reopened its borders. US Treasury yields declined for the month with the 2-year, 10-year and 30-year declining by 23, 37 and 33 basis points, ending at 4.20%, 3.51% and 3.63%, respectively. Riskier fixed income assets rallied and outperformed comparable government bonds, led by global high-yield as global markets rebounded and spreads tightened. Credit spreads narrowed across global investment-grade, global high-yield and emerging-market bonds, declining by 15, 47 and 117 basis points, respectively.

Fund Performance. The fund returned 2.25%, lagging the benchmark by 98 basis points. Below-benchmark duration positioning and underweight in government bonds detracted from performance.

Fund Strategy. In 2023, we expect major structural trends such as the increasing market share of electric vehicles sold, increased recycled content in clothing and packaging, and record installations of wind turbines and solar panels to continue. The ongoing Russia-Ukraine war has resulted in the world, particularly Europe, determined to reduce their reliance on traditional sources of energy such as oil and gas, requiring large investments in renewable energy in the coming years. In addition, we continue to see support for climate solutions and green technologies through government policies such as the Inflation Reduction Act signed by US President Joe Biden. We believe that strong ESG companies are likely to generate positive financial performance over time as investing in sustainability can deliver higher growth and returns through innovation, higher operational efficiency and better risk management.

- (a) Primarily in more than one collective investment scheme managed using a sustainable investment strategy aligned with sustainability metrics European frameworks Union Sustainable or such as the Finance Disclosure Regulation (SFDR), United Nations Sustainable Development Goals (SDG), and other globally approved recognized fund rating agencies or companies, that are registered and supervised by regulatory authorities that is a member of the International Organization of Commissions fund (IOSCO) by reputable and managed manager/s investment objectives and policies of which are generally consistent with those of the Fund; provided further combined investment in collective investment schemes should not fall below that such percent (90%) of the net asset value of the Fund. The Target Fund must be recognized as a collective investment scheme in its home jurisdiction by a regulatory authority or any regulatory authority acceptable to the BSP to supervise this CIS.
- (b) Deposit products;
- (c) Money market instruments;
- (d) Short-term tradable fixed-income instruments issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund; and, any such other instruments as may be allowed under BSP regulations.
