Notes on Product Risk Ratings

The numeric risk rating of a product is an indication of its risk on a scale of 1 to 5, with 1 being the lowest and 5 being the highest risk categories, respectively.

Higher Product Risk Ratings will tend to primarily reflect greater volatility of the market factors affecting the product’s value than for lower risk products. Higher Product Risk Ratings also apply to products with restrictions on redemptions, products that are infrequently traded, or other factors affecting the determination of a realizable market price. Product Risk Ratings are not intended to consider additional risk factors that are external to the product. Examples of such external factors include investments funded with loans and translation risk of products denominated in currencies other than the investor’s home currency.

What follows are general descriptions of the Product Risk Ratings and are for illustrative purposes only. Investment products within a particular rating may employ a variety of investment approaches but are expected to share similar return and volatility characteristics over the long term. By using investment products from several ratings, an aggregate client portfolio may be created with return and volatility characteristics that are comparable to choosing an investment product from a single rating.

Product Risk Ratings	Descriptions of Product Risk Ratings:
1 - Low Risk	Products in this category seek the lowest volatility among the risk ratings, with returns primarily driven by contractual or income-based features rather than capital appreciation, and a strong emphasis on capital stability.
2 - Low-to-Medium Risk	Products in this category aim to balance income generation with modest growth potential, accepting a moderate increase in volatility, credit risk, and return variability compared with Low Risk products.
3 - Medium Risk	Products in this category target total return through a combination of income and capital appreciation, involving a meaningful level of market, credit, and volatility risk that may result in noticeable fluctuations in value.
4 - Medium-to-High Risk	Products in this category focus on long-term growth and may experience significant volatility, drawdowns, and return dispersion over shorter periods in pursuit of higher long-term returns.
5 - High Risk	Products in this category pursue aggressive long-term capital appreciation and are subject to high levels of market volatility, multiple heightened risk factors, and the possibility of substantial or prolonged losses.
