INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve liquidity and stable income derived from a diversified portfolio of primarily short-term fixed income instruments. The Fund aims to provide excess return over the return of the 91-day Philippine Treasury Bill, net of tax.



RELATED PARTY TRANSACTIONS

The Fund has investments and trade transactions with BPI Asset Management and Trust Corporation (BPI AMTC):

BPI Family Savings Bank - PHP 1,814.05 Million; Bank of the Philippine Islands - PHP 3,077.13 Million;

BPI Direct BanKo, Inc. - PHP 250 Million; Ayala Corporation - PHP 289.80 Million; Ayala Land, Inc. - PHP 136.92 Million

Investments in the said outlets were approved by the BPI AMTC's Board of Directors. Likewise, all related party transactions are conducted on an arm's length and best execution basis and within established limits.

OUTLOOK AND STRATEGY

Market Review. The BPI Money Market Index returned 0.10% in February as money market benchmark yields fell 9 basis points (bps) on average, with the greatest yield declines seen in the 1- and 6-month benchmark tenors.

The Bureau of the Treasury (BTr) sold four tranches of Treasury Bills (T-bills) throughout the month, with each tranche comprising PHP5-7bn of 91-day, PHP5-7bn of 182-day, and PHP10bn of 364-day securities. Demand for all tenors decreased as the month progressed, but all auctions were fully awarded. Between the last auctions in this month and the previous month, yields for the 3-month securities fell 9 bps, yields for the 6-month securities fell 26 bps, and the yield of the 1-year security fell 2 bps. In the last auction of the month, the 91-, 182-, and 364-day securities were awarded at average yields of 0.875%, 1.067%, and 1.527%, respectively.

In the local economic space, January inflation came in at 4.2% year-on-year, above expectations of 3.5% and quickening from December's 3.5% figure. Food inflation due to supply chain and logistical issues and higher transportation costs due to rising oil prices were the main drivers of the headline figure's increase. Meanwhile, President Duterte rejected calls to loosen quarantine restrictions, citing his desire for more widespread vaccination before easing restrictions. With spiking inflation and slow economic growth continuing to dampen risk sentiment, the Bangko Sentral ng Pilipinas (BSP) kept policy rates steady in its February meeting but raised its full-year 2021 inflation forecast to 4% from its previous forecast of 3.2%. In statements made throughout the month, BSP Governor Benjamin Diokno stated that the spike in inflation was transitory and was being dealt with through non-monetary measures, and suggested that policy rates would remain at current levels until at least the end of the first half of the year.

Fund Performance. The Fund returned -0.04% during the month, below its benchmark by 10 bps.

Fund Strategy. The Fund favors the safety of Time Deposits. Expectations of monetary easing moving forward may depress short-term rates.

LIST OF PROSPECTIVE INVESTMENTS

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- a) Tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP; tradable fixed-income instruments issued by financial institutions or private Corps; exchange-listed securities; marketable instruments that are traded in an organized exchange; loans traded in an organized market; and, such other tradable investment outlets/categories as the BSP may allow.
- b) Tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund.
- c) Collective investment vehicles managed by reputable fund managers the investment objectives and policies of which are generally consistent with those of the Fund, subject to then existing BSP regulations.
- d) Bank deposits and such other investments allowed under regulations issued by the BSP.
