No beneficial owner shall hold more than 10% of the Fund. Any investor who owns more than 10% shall be asked to redeem the amount (or its equivalent number of units) in excess of 10% within thirty (30) calendar days.

OUTLOOK AND STRATEGY

Market Review. Global equities advanced for the third consecutive month. Markets were fuelled by a sharp increase in global economic growth, fiscal and monetary stimulus, strong corporate earnings, and accelerating vaccine rollouts. In April, the global total of COVID-19 vaccines administered so far surpassed the one billion mark, bolstering optimism that businesses in many countries can continue to reopen as lockdowns and restrictions are eased. US GDP grew at an annualized rate of 6.4% in the first quarter, and China's economy expanded by a record 18.3% in the first quarter compared to a year earlier, as the world's two largest economies continued to rapidly recover from a deep coronavirus-induced trough in early 2020. Within fixed income, global sovereign yields were mixed. US yields ended lower after four consecutive monthly increases. Credit spreads ground tighter on the back of improving global economic data. High yield generated positive total returns amid additional US fiscal stimulus and the Fed's reinforced commitment to dovish policy.

Fund Performance. The fund gained by 2.04% in April. Performance was positive across the asset classes. Within global equities, from a regional perspective, performance was led by strong gains from US equities which registered their best monthly performance since November 2020 amid a confluence of favourable themes, including a robust rebound in the economy, vaccination momentum, fiscal stimulus, and significantly better-than-expected corporate earnings. Within global fixed income, investment grade credit, followed by high yield, were the key contributors to performance as credit spreads tightened.

Fund Strategy. Encouraging vaccine progress, policy support, and gradually reopening economies make us confident in taking a pro-risk stance over a 12-month time frame. We think rising demand, higher commodity prices, low inventories, and wage pressures, among other factors, could push up inflation and inflation expectations sooner than the market expects. We are moderately bullish on global equities. We think a vaccine-driven reopening will be the catalyst for a continued rotation from growth- to value-oriented exposures; but retain a diversified portfolio from a factor perspective. We are leaning the portfolio toward emerging markets (EM) and Asia. Given large output gaps and low levels of valuations, sentiment, and positioning in these areas, we think a rotation into EM and Asia will be an enduring theme for the rest of the year. On fixed income, low yield levels, steady state monetary policy and bigger fiscal stimulus continue to point towards a challenging year. We are moderately bearish on government bonds and have a modestly positive view on IG corporate spreads. Lastly, our view on EM debt has improved and we see a better developed market backdrop and extraordinary policy supporting EM assets. We believe there are attractive opportunities in the higher-yielding local rates and currency markets, especially in corporate issuers. Finally, we believe this market environment to be supportive of security selection and active management. Against this backdrop, income investors will be best served through a highly diversified portfolio of multi-asset income producing assets that can be dynamically adjusted as market conditions evolve.

LIST OF PROSPECTIVE INVESTMENTS

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- a) Primarily in a single collective investment scheme whose investment objective is to provide investment results that maximize income; provided further that such CIS is approved or registered and supervised by a regulatory authority that is a member of the International Organization of Securities Commissions (IOSCO) and managed by reputable fund manager/s; provided further that the investment in the said collective investment scheme should at least be ninety percent (90%) of the total assets of the Fund. The target Fund must be recognized as a collective investment scheme in its home jurisdiction by a regulatory authority or any regulatory authority acceptable to the BSP to supervise the CIS.
- b) Primarily short-term tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP; tradable securities issued by the government of a foreign country, any political subdivision/agency of a foreign country or any supranational entity; tradable fixed- income instruments issued by foreign or local financial institutions or private corporations; exchange-listed securities; marketable instruments that are traded in an organized exchange; loans traded in an organized market; and, such other tradable investments outlets/ categories as the BSP may allow. Provided, that, a financial instrument is regarded as tradable if two-way prices are quoted, readily available or regularly available from an exchange, dealer, broker, industry group, pricing service or regulatory agency, and those prices represent actual and regularly occurring market transactions on an arm's length basis.
- c) Primarily short-term tradable fixed-income instruments issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund; and, any such other instruments as may be allowed under BSP regulations. Investment with related interests shall be in accordance with Subsection X410.12 (a) of the Manual of Regulations for Banks.
- d) The principal investments of the Fund will be denominated in, but not limited to the US Dollar. The target fund invests in securities denominated in other currencies
- e) Bank deposits or tradable debt instruments issued by the BSP.
- f) Such other investments allowed under regulations issued by the BSP.
