INVESTMENT OBJECTIVE AND STRATEGY

The Fund, operating as a Feeder Fund, intends to achieve for its Participants stable income with a secondary focus on long term capital growth by investing in a Target Fund that invests in diversified portfolio of global equity and fixed income instruments. **The Fund shall use 35% MSCI World Index (USD Hedged) + 5% MSCI Emerging Markets Index (Unhedged) + 25% Bloomberg Barclays Global Aggregate Corporate Index (USD Hedged) + 15% Bloomberg Barclays Global High Yield Index (USD Hedged) + 20% FTSE World Government Bond 10+ Years Index (USD Hedged) only as a reference benchmark. Given its focus on income, the Fund does not intend to outperform this benchmark.**

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI Invest US Dollar Income Feeder Fund is suitable only for investors who:

- Are classified as aggressive based on their risk profile.
- Seek regular income with a secondary focus on capital appreciation over the medium to long term.
- Are comfortable with the risks of a global multi-asset fund.

Participation in the Fund shall be open to Participants with legal capacity to contract and who are not considered US persons under the US securities and tax laws, subject to the other conditions, rules or provisions stated in the Plan Rules and those established by the Trustee. No beneficial owner shall hold more than 10% of the Fund. Any investor who owns more than 10% shall be asked to redeem the amount (or its equivalent number of units) in excess of 10% within thirty (30) calendar days.

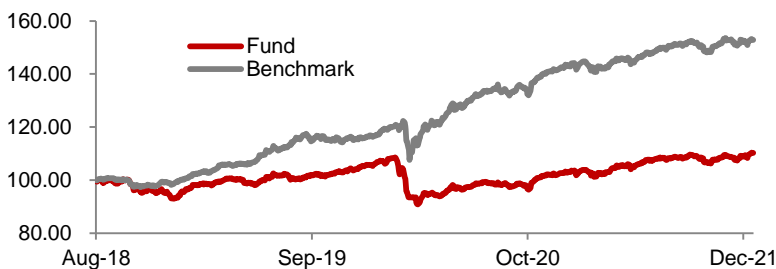

OUTLOOK AND STRATEGY

Market Review. Global equities rose in December. The rapid proliferation of the Omicron COVID-19 variant across the globe drove equity volatility sharply higher, although the variant's impact on financial markets was tempered by evidence that it poses less-severe health consequences than its predecessors. In response to persistent inflation pressures, many central bank policymakers in developed markets began unwinding their pandemic-era stimulus measures and setting a course for higher interest rates. The Bank of England was the first major central bank to hike its policy rate, while the US Federal Reserve (Fed) announced it would end its asset purchase program in March and projected three rate hikes in 2022. The European Central Bank (ECB) will conclude net purchases under its pandemic emergency purchase program (PEPP) in March. Most global sovereign yields generally moved upward, reflecting hawkish central bank rhetoric, while Omicron fears ebbed. US Treasury yields rose, particularly in the latter half of the month, following the Fed's hawkish tone. Within EM, local markets debt outperformed external debt, in US-dollar terms.

Fund Performance. The fund gained by 2.44% in December. Within global equities, from a regional perspective, performance was positive across the regions, led by US equities as it rallied due to strong equity inflows, and potentially less-severe economic impacts from the Omicron variant amid headwinds posed by central bank policy shifts, ongoing supply-chain problems, and inflation pressures. Within global fixed income, high yield credit was the largest contributor to performance with spreads tightening as concerns about the rapid spread of Omicron were tempered by the variant's relatively low severity of infection.

Fund Strategy. While the economic backdrop may not be quite as supportive for the market in 2022 as it was in 2021, we maintain a pro-risk stance. As the world awaits clarity on effects of the Omicron variant on global reopening or renewed lockdowns, we expect to see volatility persist through this period of uncertainty. We are moderately bullish on global equities and we believe that this period of volatility will present attractive opportunities. Our expectations for 2022 is one of reflationary growth and we expect COVID concerns to fade, consumer spending to persist, and the economic recovery to continue but with higher inflation and less policy stimulus. On a regional basis, we prefer developed over emerging markets (EM) given China's slowdown and the hardships EM countries face post-pandemic, including slower growth, high inflation, worse fiscal deficits, and greater political volatility. Within fixed income, we see a tumultuous period for rates in the months ahead as markets try to divine how central banks will respond to inflation pressures and broader market reopening. We are moderately bearish on government bonds, investment grade and high yield credit. We have also shifted to be moderately bearish on EM debt which continues to be challenged due to COVID-19 and China's regulatory crackdown. Finally, we believe this market environment to be supportive of security selection and active management. Against this backdrop, income investors will be best served through a highly diversified portfolio of multi-asset income producing assets that can be dynamically adjusted as market conditions evolve.

LIST OF PROSPECTIVE INVESTMENTS

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- Primarily in a single collective investment scheme whose investment objective is to provide investment results that maximize income; provided further that such CIS is approved or registered and supervised by a regulatory authority that is a member of the International Organization of Securities Commissions (IOSCO) and managed by reputable fund manager/s; provided further that the investment in the said collective investment scheme should at least be ninety percent (90%) of the total assets of the Fund. The target Fund must be recognized as a collective investment scheme in its home jurisdiction by a regulatory authority or any regulatory authority acceptable to the BSP to supervise the CIS.
- Primarily short-term tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP; tradable securities issued by the government of a foreign country, any political subdivision/agency of a foreign country or any supranational entity; tradable fixed-income instruments issued by foreign or local financial institutions or private corporations; exchange-listed securities; marketable instruments that are traded in an organized exchange; loans traded in an organized market; and, such other tradable investments outlets/ categories as the BSP may allow. Provided, that, a financial instrument is regarded as tradable if two-way prices are quoted, readily available or regularly available from an exchange, dealer, broker, industry group, pricing service or regulatory agency, and those prices represent actual and regularly occurring market transactions on an arm's length basis.
- Primarily short-term tradable fixed-income instruments issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund; and, any such other instruments as may be allowed under BSP regulations. Investment with related interests shall be in accordance with Subsection X410.12 (a) of the Manual of Regulations for Banks.
- The principal investments of the Fund will be denominated in, but not limited to the US Dollar. The target fund invests in securities denominated in other currencies.
- Bank deposits or tradable debt instruments issued by the BSP.
- Such other investments allowed under regulations issued by the BSP.
