

OUTLOOK AND STRATEGY

Market Review. Global equities rebounded in October as risk sentiment was bolstered by strong corporate earnings, robust global equity inflows, improving COVID-19 trends and vaccine coverage. However, persistent supply-chain disruptions and uncertainty about the inflation outlook triggered anxiety about the global economic recovery. Inflation swelled across most developed markets, ratcheting up pressure on central banks to start scaling back some of their extraordinary monetary support and prompting markets to pull forward the time frame of interest-rate hikes by the US Federal Reserve (Fed) and the European Central Bank (ECB). A combination of strong demand and depleted supplies drove oil, gas, and coal prices sharply higher, sending shock waves through economies across the globe. Most global sovereign short-end yields rose, driven by hawkish rhetoric from central banks on the back of inflationary pressures. US Treasury yields increased, and the yield curve flattened amid supply-chain concerns and rising costs. High yield generated negative total returns, as US Treasury yields continued to move higher.

Fund Performance. The fund gained by 1.62% in October. Positive performance was led by global equities followed by modest gains from global fixed income. Within global equities, from a regional perspective, performance was mixed across the regions, with gains from the United States and Europe offset by losses from Japan and the EM. US equities registered their largest monthly gain of the year, as inflation anxiety was outweighed by better COVID-19 trends, higher-than-expected corporate earnings, strong US equity inflows, and improved prospects for additional fiscal stimulus. Within fixed income, on a sector level, investment grade credit was the largest contributor to performance, driven by US investment grade credit. Overall gains were modestly offset by losses from high yield credit and EM debt.

Fund Strategy. Vaccination progress and policy support make us confident in taking a pro-risk stance, but inflation concerns curb our enthusiasm. Within global equities, we are moderately bullish but have slightly tempered the overall pro-cyclical bias of our active positions due to rising inflation and decelerating growth in DM. Within fixed income, we believe that interest rates are vulnerable to higher or more persistent inflation. Policy normalization is imminent with DM central banks looking to get out of quantitative easing. We are moderately bearish on government bonds, investment grade and high yield credit. We are modestly bullish on Emerging Market debt as valuations are more attractive on a relative basis. Finally, we believe this market environment to be supportive of security selection and active management. Against this backdrop, income investors will be best served through a highly diversified portfolio of multi-asset income producing assets that can be dynamically adjusted as market conditions evolve.

LIST OF PROSPECTIVE INVESTMENTS

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- a) Primarily in a single collective investment scheme whose investment objective is to provide investment results that maximize income; provided further that such CIS is approved or registered and supervised by a regulatory authority that is a member of the International Organization of Securities Commissions (IOSCO) and managed by reputable fund manager/s; provided further that the investment in the said collective investment scheme should at least be ninety percent (90%) of the total assets of the Fund. The target Fund must be recognized as a collective investment scheme in its home jurisdiction by a regulatory authority or any regulatory authority acceptable to the BSP to supervise the CIS.
- b) Primarily short-term tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP; tradable securities issued by the government of a foreign country, any political subdivision/agency of a foreign country or any supranational entity; tradable fixed- income instruments issued by foreign or local financial institutions or private corporations; exchange-listed securities; marketable instruments that are traded in an organized exchange; loans traded in an organized market; and, such other tradable investments outlets/ categories as the BSP may allow. Provided, that, a financial instrument is regarded as tradable if two-way prices are quoted, readily available or regularly available from an exchange, dealer, broker, industry group, pricing service or regulatory agency, and those prices represent actual and regularly occurring market transactions on an arm's length basis.
- c) Primarily short-term tradable fixed-income instruments issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund; and, any such other instruments as may be allowed under BSP regulations. Investment with related interests shall be in accordance with Subsection X410.12 (a) of the Manual of Regulations for Banks.
- d) The principal investments of the Fund will be denominated in, but not limited to the US Dollar. The target fund invests in securities denominated in other currencies.
- e) Bank deposits or tradable debt instruments issued by the BSP.
- f) Such other investments allowed under regulations issued by the BSP.
