INVESTMENT OBJECTIVE AND STRATEGY

The Fund, operating as a Feeder Fund, aims to achieve long-term capital appreciation by investing in a Target Fund with a diversified portfolio of attractively-priced stocks with high dividend yields in the Asia Pacific region. It aims to outperform its benchmark which is the MSCI AC Asia Pacific ex-Japan High Dividend Net Return USD Index.

CLIENT SUITABILITY

Market/Price

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust / Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The Odyssey Asia Pacific High Dividend Equity Feeder Fund is suitable only for investors who:

- Are at least classified as aggressive based on their risk profile
- Have an investment horizon of at least five (5) years



OUTLOOK AND STRATEGY

Market Review. Asian equities rebounded in August as the recovery in the region gathers momentum supported by rising inoculation rates, economic re-opening, and dovish comments by the Federal Reserve during the annual Jackson Hole symposium. The MSCI Asia ex-Japan Index rose by 2.31% for the month. Thailand, Philippines, and India were the best performers in the region. On the other hand, China markets lagged as Chinese government authorities released a five-year blueprint calling for greater regulation, expanding beyond the technology sector. Overall, growth outperformed high dividend and value for the month.

Fund Performance. The fund returned 1.71% in August, outperforming the benchmark by 96 basis points. On the positive side, underweight in consumer discretionary and communication services added value as the Chinese internet sector remained under pressure due to a regulatory overhang. On the negative side, stock selection in materials detracted from performance.

Fund Strategy. Recent market sell-offs and COVID resurgences underscore the volatility that will be the likely mainstay for the rest of the year and possibly into 2022. Investors will aim to balance inflation concerns and high valuations with economic optimism. The fund will maintain a diversified positioning in quality franchises, defensives and value cyclicals for both income and growth opportunities.

- Tradable securities issued or guaranteed by multilateral institutions such as the Asian Development Bank (ADB), International Monetary Fund (IMF) and World Bank;
- Tradable securities issued by a government of a foreign country, any political subdivision of a foreign country or any supranational entity; e)
- f) Common shares, preferred shares, and convertible preferred share listed on the Philippine Stock Exchange or any organized stock exchange;
- Shares offered in an Initial Public Offering (IPO), provided that the company will be listed on the Philippine Stock Exchange or any organized stock g) exchange within the normal listing period (approximately 30 days from the start of the offer period);
- h) Exchange-listed securities and warrants of such securities;
- Marketable instruments that are traded in an organized exchange;
- j) Loans traded in an organized market; and
- Such other tradable investments outlets/categories as may be approved by the relevant authority and allowed by the BSP.

INVESTMENT OBJECTIVE OF THE TARGET FUND

JP Morgan Asia Equity Dividend Fund aims to provide income and long term capital growth by investing primarily in equity securities of companies in the Asia Pacific region (excluding Japan) that the Investment Manager expects to pay dividends. The benchmark of the Fund is MSCI AC Asia Pacific ex-Japan Net Index.
