INVESTMENT OBJECTIVE AND STRATEGY

The objective of this Fund is to attain long-term capital growth for Peso investors. To achieve this, the Fund will be invested in a concentrated portfolio of stocks listed on the Philippine Stock Exchange. The Fund seeks to outperform the Philippine Stock Exchange Index (PSEi).

CLIENT SUITABILITY

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund which may be obtained from the Trustee, before deciding to invest.

The Odyssev Philippine Equity Fund is suitable only for investors who:

- Are at least classified as aggressive based on their risk profile
- Have an investment horizon of at least five (5) years

The Fund invests in a concentrated portfolio of stocks listed in the Philippine Stock Exchange, expositing investors to potentially larger losses from a decline in stock prices, compared to funds tracking the index or employing a value style bias/ strategy. OUTLOOK AND STRATEGY

Market Review. The Philippine Stock Exchange (PSEi) took a huge hit in July, dropping by 9.20% to 6,270.23 on fears of another wave of COVID-19 sparked by the rising delta variant cases. Credit rating agency, Fitch, maintained the country's BBB rating but revised the outlook from stable to "negative" also weighed-in on investor concerns. Volume was thinner for July with Average Daily Turnover at US\$117 million or 19.3% lower month-on-month. Foreigners were net sellers yet again, registering at US\$184.5 million for the month.

In terms of individual stock performances, main advancers were: EMP (+9.22%), and GLO (+1.09%); while the main laggards include: LTG (-24.26%), MEG (-14.24%) and SMPH (-13.04%).

Fund Performance. The fund returned -9.15% in July. Year-to-date, it outperformed the benchmark by 16 basis points with a return of -12.02%.

Fund Strategy. We anticipate further volatility due to threat of the rising delta variant. Despite this, we are still strategic long-term buyers of Philippine equities. We favor quality names or position on cyclicals. We will continue to be nimble and buy on market dips.

- a) Common shares, preferred shares, and convertible preferred shares listed on the Philippine Stock Exchange;
- b) Shares offered in an Initial Public Offering (IPO), provided that the company will be listed on the Philippine Stock Exchange within the normal listing period (approximately 30 days from the start of the offer period);
- c) Bank Deposits;
- d) Primarily short term securities issued by or guaranteed by the Philippine government, or by the BSP;
- e) Primarily short term tradable securities issued or guaranteed by multilateral institutions such as the Asian Development Bank (ADB), International Monetary Fund (IMF), and World Bank;
- f) Primarily short term exchange-listed securities;
- g) Primarily short term marketable instruments that are traded in an organized exchange;
- h) Primarily short term loans traded in an organized market; and
- i) Such other tradable investments outlets/categories as may be approved by the relevant authority and allowed by the BSP.
