

#### **OUTLOOK AND STRATEGY**

**Market Review**. The BPI Money Market Index returned 0.15% in August, while benchmark short-term government yields rose 23 basis points (bps) on average. Average daily trading volume fell to PHP14.46 billion from July's PHP14.95 billion with trades mostly seen on the belly (5- to 10-year papers) of the curve.

The Bureau of the Treasury (BTr) held five Treasury Bill auctions in August. The last auction for the month was rejected as yields for Treasury Bills remain elevated given rate hike expectations. Average rates for the last awarded auction of the 91-day paper, 182-day paper and 364-day paper were at 2.070%, 3.336% and 3.782%. Towards month-end, the BTr released its September auction schedule, announcing four FXTN issuances (3.5-, 10-, 7-, and 16-year tenors) and four Treasury Bill auctions.

In the local economic space, July inflation rose by 6.4% year-on-year, the fastest pace since November 2018. Price pressures remain elevated for the month driven mostly by expensive food, transport, and utility costs. Consequently, the Bangko Sentral ng Pilipinas (BSP) raised their policy rates by 50bps during their Monetary Board meeting on August 18. Moreover, the central bank revised their inflation forecast upward to 5.4% for 2022. BSP Governor Felipe Medalla kept a hawkish stance remarking further interest rate hikes not to be ruled out for the rest of the year.

Fund Performance. The Fund returned 0.00% during the month, below its benchmark by 15 basis points.

**Fund Strategy**. The Fund continues to maintain its holdings in short duration government securities. Expectations of rising rates moving forward may provide an opportunity for better yielding investment outlets.

#### LIST OF PROSPECTIVE INVESTMENTS

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- a) Primarily short-term tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP; marketable instruments that are traded in an organized exchange; investment outlets/ categories the BSP allow. Provided, that, a financial instrument is regarded as tradable if quoted two-way prices are readily available and regularly available from an exchange, dealer, broker, industry group, pricing service or regulatory agency, and those prices represent actual and regularly occurring market transactions on an arm's length basis.
- b) Primarily short-term tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund or any such instrument as may be allowed under BSP regulations. Investment with related interests shall be in accordance with Subsection X 410.12 (a) of the Manual of Regulations for Banks.
- c) Bank deposits or tradable debt instruments issued by the BSP.
- d) Such other investments allowed under regulations issued by the BSP.
