INVESTMENT OBJECTIVE AND STRATEGY

The Fund is for US Dollar investors who want to achieve capital appreciation and income growth over a period of time. To achieve this, the Fund will be invested in a diversified portfolio of US dollar-denominated fixed income instruments issued by the Philippine government, corporations, & financial institutions. The Fund aims to outperform its benchmark, the JP Morgan Chase Asia Total Return Philippines Index.

CLIENT SUITABILITY

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust / Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The Odyssey Philippine Dollar Bond Fund is suitable only for investors who:

- · Are at least classified as aggressive based on their risk profile
- Have an investment horizon of at least five (5) years



OUTLOOK AND STRATEGY

Market Review. The JP Morgan Asia Credit Index (JACI) Philippines lost 2.49% in June as Philippine dollar-denominated bonds tracked the sell-off in US Treasuries.

US Treasuries sold off as market players continued to price in further interest rate increases on top of the past few months' hikes. During its June policy meeting, the US Federal Reserve raised benchmark rates by 75 basis points, the largest hike seen since 1994, to combat elevated inflation levels. Rhetoric from various Federal Reserve likewise confirmed that further tightening would be necessary to curb price increases. However, market concerns that an overly rapid pace of rate hikes may lead to an economic recession caused heightened volatility in the global bonds space. The US 10-year benchmark yield rose to as much as 3.47% in June before closing the month at the 3.01% level.

In the local economic space, May inflation rose to 5.4% year-on-year, exceeding the central bank's target range of 2-4% for the year. The figure continued to be driven by rising food and energy costs. Consequently, the Bangko Sentral ng Pilipinas (BSP) hiked policy rates by 25 basis points during its June meeting, marking its second increase for the year. The BSP officials will continue to monitor economic conditions and adjust monetary policies as they see fit.

Fund Performance. The Fund lost 1.55% for the month, below its benchmark by 94 basis points. In term of YTD performance, the fund returned 9.70%, outperforming benchmark by 204 bps.

Fund Strategy. The Fund looks to maintain a neutral duration position and opportunistically add exposure to corporate issuers to enhance yield. Global events remain likely to add volatility. Investors in a bond fund must be prepared to withstand volatility as higher investment value is typically achieved over the medium to long term.

LIST OF PROSPECTIVE INVESTMENTS

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- a) Bank deposits and such other investments allowed under regulations issued by the BSP;
- b) Securities issued by or guaranteed by the Philippine government, or by the BSP;
- c) Tradable securities issued or guaranteed by multilateral institutions such as the Asian Development Bank (ADB), International Monetary Fund (IMF) and World Bank;
- d) Tradable securities issued by the government of a foreign country, any political subdivision of a foreign country or any supranational entity;
- e) Exchange-listed securities;
- f) Marketable instruments that are traded in an organized exchange;
- g) Loans traded in an organized market;
- h) Such other tradable investments outlets/categories as may be approved by the relevant authority and allowed by the BSP; and
- i) The Trustee may invest in allowable investments denominated in any acceptable foreign currency.
