## **INVESTMENT OBJECTIVE AND STRATEGY**

The Fund, operating as a Feeder Fund, intends to achieve for its Participants long term capital growth by investing in a Target Fund that invests in stocks in the technology sector. It aims to provide excess return over the MSCI AC World Information Technology Index. Pursuant to existing BSP rules and regulations, as a Feeder Fund, this Fund is mandated to invest at least 90% of its assets in a single collective investment scheme.

#### **CLIENT SUITABILITY**

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI World Technology Feeder Fund is for investors who:

- Are at least classified as aggressive based on their risk profile.
- Have an investment horizon of at least five (5) years.

Participation in the Fund shall be open to Participants with legal capacity to contract and who are not considered US persons under the US securities and tax laws, subject to the other conditions, rules or provisions stated in the Plan Rules and those established by the Trustee. No beneficial owner shall hold more than 10% of the Fund. Any investor who owns more than 10% shall be asked to redeem the amount (or its equivalent number of units) in excess of 10% within thirty (30) calendar days.

## Market/Price Risk:



#### **OUTLOOK AND STRATEGY**

Market Review. Global equity markets declined in September. The Federal Reserve kept rates steady but remained hawkish in tone, keeping the possibility of another rate hike before yearend. The Federal Open Market Committee (FOMC) members also projected that rate cuts will be pushed back, with median end-2024 and end-2025 target rate projections being forecasted 50 bps higher compared to June projections. Sentiment weakened and risk assets sold off as interest rates rose and rate cut expectations have been pushed back, reinforcing the higher for longer narrative. In terms of business activity, the US economy barely remained in the expansionary territory, with its composite PMI barely unchanged from 50.2 to 50.1 month-on-month, driven by further contraction in the manufacturing sector. The MSCI All Country World Index returned -4.10% for the month, with developed markets, underperforming its emerging counterparts. Across other regional markets, Chinese and Hong Kong equities sold-off amid the region's challenged real estate sector and weaker than expected economic data. The MSCI ACWI Information Technology index declined by 6.5%, underperforming broad equity markets as interest rates rose for the month.

**Fund Performance.** The fund returned -5.69% in September, outperforming the benchmark by 81 basis points. Stock selection within hardware was the largest contributor to relative returns.

Fund Strategy. Macroeconomic headwinds continue in 2023, leading enterprises to remain conservative with IT spending. We believe that concerns about interest rates and inflation have largely been priced into tech equities. However, there remains uncertainty regarding the severity and duration of a potential economic slowdown. Recent advancements in artificial intelligence have brought new momentum into the sector, negating the impact from macro weakness. While the initial beneficiaries were the mega-cap technology names building the infrastructure to train AI models, we see wide opportunities in the space aligned with the theme moving forward. While growth assets have been penalized due to rising rate concerns, the companies within the portfolio continue to be underpinned by compelling fundamentals and powerful long-term secular growth drivers. The secular growth trends driving technology are multi-year transformations that are expected to persist, regardless of the macroeconomic environment or geopolitical risk. The fund will continue to focus on these long-term secular themes such as artificial intelligence, cloud computing, electric vehicles, metaverse, space and quantum computing.

#### LIST OF PROSPECTIVE INVESTMENTS

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- (a) Primarily in a single collective investment scheme whose investment objective is to provide investment results in excess of the return of the MSCI AC World Information Technology Index; provided further that such CIS is approved or registered and supervised by a regulatory authority that is a member of the International Organization of Securities Commissions (IOSCO) and managed by reputable fund manager/s; provided further that the investment in the said collective investment scheme should at least be ninety percent (90%) of the total assets of the Fund. The Target Fund must be recognized as a collective investment scheme in its home jurisdiction by a regulatory authority or any regulatory authority acceptable to the BSP to supervise this CIS.
- (b) Short-term tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP; tradable securities issued by the government of a foreign country, any political subdivision/agency of a foreign country or any supranational entity; tradable fixed-income instruments issued by foreign or local financial institutions or private corporations; exchange- listed securities; marketable instruments that are traded in an organized exchange; loans traded in an organized market; and, such other tradable investments outlets/ categories as the BSP may allow. Provided, that, a financial instrument is regarded as tradable if two-way prices are quoted, readily available or regularly available from an exchange, dealer, broker, industry group, pricing service or regulatory agency, and those prices represent actual and regularly occurring market transactions on an arm's length basis.
- (c) Short-term tradable fixed-income instruments issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund; and, any such other instruments as may be allowed under BSP regulations. Investment with related interests shall be in accordance with Section 414-Q of the Manual of Regulations for Non-Bank Financial Institutions.
- (d) The principal investments of the Fund will be denominated in, but not limited to the U.S. Dollar. The target fund invests in securities denominated in other currencies.
- (e) Bank deposits or tradable debt instruments issued by the BSP.
- (f) Such other investments allowed under regulations issued by the BSP.

## **INVESTMENT OBJECTIVE OF TARGET FUND**

The BlackRock World Technology Fund seeks to maximize total return. The Fund invests globally at least 70% of its total assets in the equity securities of companies whose predominant economic activity is in the technology sector.
