

**INVESTMENT OBJECTIVE AND SUMMARY**

The Fund, operating as a Fund-of-Funds, seeks to achieve long-term capital growth by investing in a diversified portfolio of global equity and fixed income collective investment schemes which integrate environmental, social, and governance criteria in its investment process, including the incorporation of sustainability goals and facilitation of flow of funds towards green economic activities, climate change mitigation and adaptation projects, and other positive environmental and social impact initiatives.



<b>MSCI All Country World Index Net Total Return USD Index</b>	The MSCI ACWI Index, MSCI's flagship global equity index, is designed to represent performance for the full opportunity set of large- and mid-cap stocks across 23 developed and 24 Emerging Markets. With 2,757 constituents, the index covers approximately 85% of the global investable equity opportunity set. The index is based on the MSCI Global Investable Market Indexes (GIMI) Methodology – a comprehensive and consistent approach to index construction that allows for meaningful global views and cross regional comparisons across all market capitalization size, sector and style segments and combinations. This methodology aims to provide exhaustive coverage of the relevant investment opportunity set with a strong emphasis on index liquidity, investability and replicability. The MSCI Total Return Indices measure the market performance, including price performance and income from regular cash distributions (cash dividend payments or capital repayments). MSCI's Daily Total Return (DTR) methodology reinvests regular cash distributions in indices on the ex-date of such distributions.
<b>Bloomberg Barclays Global Aggregate Bond Index (Unhedged)</b>	The Bloomberg Global Aggregate Index is a flagship measure of global investment grade debt from twenty-eight local currency markets. This multi-currency benchmark includes treasury, government-related, corporate and securitized fixed-rate bonds from both developed and emerging markets issuers. A component of the Multiverse Index, the Global Aggregate Index was created in 2000, with index history backfilled to January 1, 1990.

## OUTLOOK AND STRATEGY

**Market Review.** Global equities advanced in December, supported by resilient earnings and supportive policy measures that underpinned elevated valuations. In the US, inflation remained contained, enabling decisive policy action to address a softening labor market. Both the US Federal Reserve and Bank of England lowered policy rates by 25 basis points (bps), while the Fed introduced new Reserve Management Purchases to bolster liquidity.

The European Central Bank held rates steady against a relatively positive economic backdrop and subdued inflation. The Bank of Japan raised its policy rate by 25 bps, to 0.75%, signaling further hikes in 2026 to support the currency as the economy transitions through the impacts of tariffs. In China, the Manufacturing Purchasing Managers' Index moved into expansionary territory for the first time in eight months and the country's trade surplus surpassed US\$1 trillion for the first time. However, weak domestic demand and a sustained property slump continued to weigh on China's economy. Geopolitical and trade tensions persisted, yet the impact of US tariffs has been more benign than feared, as the US statutory tariff rate declined to 15.7% by year's end, down from a daunting 30% peak set in April.

The Bloomberg Global-Aggregate Bond Index (Unhedged USD) returned 0.26% in December. Cooling U.S. inflation and mixed labor data provided the Federal Reserve room to ease policy. On December 10, the Fed cut rates by 25 basis points, signaling a more accommodative stance. However, strong demand at mid-month U.S. Treasury auctions pushed long-term yields higher, resulting in a steeper curve, short-term yields declined while long-term yields rose.

Across global fixed income markets, yield movements were mixed. Government Bonds (Govies) and Emerging Market (EM) rates generally rose, while Investment-Grade (IG) corporates and High Yield (HY) spreads tightened. In Asia, Japan's 10 yr JGBs yield jumped 27 bps to 2.07%, a 17 year high, after the Bank of Japan (BoJ) raised rates by 25 bps to 0.75%, ending decades of ultra-dovish policy. In Europe, UK 10-year Gilts edged up 3 bps to 4.48%, while German 10-year bunds rose by 17bps to 2.86%, reflecting ECB's neutral stance, global yield pressures, and geopolitical sentiment.

Emerging market debt posted positive returns, with hard-currency EM debt up 0.7% and local-currency EM debt up 1.5% in USD terms. In the Philippines, dollar-denominated bond yields rose and the curve steepened, tracking U.S. Treasury movements. The JP Morgan Asia Credit Index – Philippines returned 0.39% for the month.

**Fund Performance.** The fund returned 0.57%, lagging the benchmark by 47 basis points. Security selection within the fund detracted performance.

**Fund Strategy.** We expect major structural trends in sustainability, such as increasing market share of electric vehicles and record installation of wind turbines and solar panels, to continue. The ongoing Russia-Ukraine war, has resulted in the world, particularly Europe, determined to reduce their reliance on traditional sources of energy such as oil in gas, requiring large investments in renewable energy in the coming years. In addition, we continue to see support for green technologies through government policies across the globe. We believe that strong ESG companies are likely to generate positive financial performance over time as investing in sustainability can deliver higher growth and returns through innovation, higher operational efficiency and better risk management.

## LIST OF PROSPECTIVE INVESTMENTS

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

(a) Primarily in more than one collective investment scheme ("CIS") managed using a sustainable investment strategy aligned with sustainability metrics or frameworks such as the European Union Sustainable Finance Disclosure Regulation (SFDR), United Nations Sustainable Development Goals (SDG), and other globally recognized fund rating agencies or companies, that are approved or registered and supervised by regulatory authorities that is a member of the International Organization of Securities Commissions (IOSCO) and managed by reputable fund manager/s the investment objectives and policies of which are generally consistent with those of the Fund; provided further that such combined investment in collective investment schemes should not fall below ninety percent (90%) of the net asset value of the Fund. The Target Fund must be recognized as a collective investment scheme in its home jurisdiction by a regulatory authority or any regulatory authority acceptable to the BSP to supervise this CIS;

(b) Deposits products;

(c) Money market instruments;

(d) Short-term tradable fixed-income instruments issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund; and, any such other instruments as may be allowed under BSP regulations. Investment with related interests shall be in accordance with Section 414-Q of the MORNBF1;

(e) Such other investments suitable to the nature, classification, and strategy of the Fund, as allowed by prevailing regulations.

(f) The principal investments of the Fund will be denominated in, but not limited to, the following major currencies: U.S. Dollar, Euro, British Pound, Canadian Dollar, Australian Dollar, Swiss Franc, Danish Kroner, and Japanese Yen.

The BPI Sustainable Global Balanced Fund-of-Funds incurs trust fee payable to the Trustee on top of the management fee/s charged by the Target Fund/s. Said fees and other expenses are already included in the computation of the Net Asset Value per Unit, which is the price at which investors subscribe and redeem units of the Fund.
