INVESTMENT OBJECTIVE AND STRATEGY

The Fund, operating as a Feeder Fund, intends to achieve long-term capital growth by investing in a Target Fund that aims to provide returns in excess of the return of the MSCI Europe Index. Pursuant to existing BSP rules and regulations, as a Feeder Fund, this Fund is mandated to invest at least 90% of its assets in a single collective investment scheme.

CLIENT SUITABILITY

Liquidity Risk:

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI European Equity Feeder Fund is for investors who:

- Are at least classified as aggressive based on their risk profile.
- Have an investment horizon of at least five (5) years.

Participation in the Fund shall be open to Participants with legal capacity to contract and who are not considered US persons under the US securities and tax laws, subject to the other conditions, rules or provisions stated in the Plan Rules and those established by the Trustee. No beneficial owner shall hold more than 10% of the Fund. Any investor who owns more than 10% shall be asked to redeem the amount (or its equivalent number of units) in excess of 10% within thirty (30) calendar days.



OUTLOOK AND STRATEGY

Market Review. European equities increased in August. The eurozone economy showed signs of resilience, while the EU and US established a framework agreement on trade, which caps US tariffs at 15% on most EU goods and eliminates the 10% European tariff on US goods. Eurozone business activity increased for the eighth consecutive month as the HCOB Flash Eurozone Composite PMI rose to 51.1 in August, well above market expectations and the crucial 50.0 mark that separates contraction from expansion. New orders increased for the first time since May 2024, helping overall business activity to expand at the fastest pace in 15 months despite persistent weakness in exports and trade uncertainty. Europe's manufacturing sector recorded its first expansion since June 2022, and eurozone employment advanced for the sixth straight month.

The central banks of Sweden and Norway left interest rates unchanged, while the Bank of England lowered rates by 25 basis points despite concerns among some policymakers about high inflation. Annual eurozone headline inflation rose to 2.1% in July, while core inflation remained steady at 2.3%.

The MSCI Europe Index Net returned 1.1% over the month. Within the index, eight out of 11 sectors rose for the period. Health care and consumer staples were the top performing sectors, while information technology and utilities were the bottom performing sectors over the period.

Fund Performance. The fund returned 2.47% in August, lagging the benchmark by 97 basis points.

Fund Strategy. We are monitoring broader inflation trends, longer-term yields, recession risk, the situation in Ukraine and the Middle East and the evolving European regulatory framework. We continue to assess companies for their long-term fundamental attractiveness based on existing investment criteria and incorporate the implications of potential challenges amidst geopolitical and macroeconomic risks. Our preferred sectors are industrials, and our preferred regions are the United Kingdom and Ireland.

LIST OF PROSPECTIVE INVESTMENTS

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- (a) Primarily in a single collective investment scheme whose investment objective is to provide investment results in excess of the return of the MSCI Europe Index; provided further that such CIS is approved or registered and supervised by a regulatory authority that is a member of the International Organization of Securities Commissions (IOSCO) and managed by reputable fund manager/s; provided further that the investment in the said collective investment scheme should at least be ninety percent (90%) of the total assets of the Fund. The Target Fund must be recognized as a collective investment scheme in its home jurisdiction by a regulatory authority or any regulatory authority acceptable to the BSP to supervise this CIS. Such collective investment schemes must not have any investment exposure in other collective investment schemes.
- (b) Primarily short-term tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP; tradable securities issued by the government of a foreign country, any political subdivision/agency of a foreign country or any supranational entity; tradable fixed-income instruments issued by foreign or local financial institutions or private corporations; exchange-listed securities; marketable instruments that are traded in an organized exchange; loans traded in an organized market; and, such other tradable investments outlets/ categories as the BSP may allow. Provided, that, a financial instrument is regarded as tradable if two-way prices are quoted, readily available or regularly available from an exchange, dealer, broker, industry group, pricing service or regulatory agency, and those prices represent actual and regularly occurring market transactions on an arm's length basis
- (c) Primarily short-term tradable fixed-income instruments issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund; and, any such other instruments as may be allowed under BSP regulations. Investment with related interests shall be in accordance with Subsection X410.12 (a) of the Manual of Regulations for Banks.
- (d) The principal investments of the Fund will be denominated in, but not limited to the U.S. Dollar.
- (e) Bank deposits, BSP special deposit account or tradable debt instruments issued by the BSP.
- (f) Such other investments allowed under regulations issued by the BSP.

INVESTMENT OBJECTIVE OF TARGET FUND

The Wellington Strategic European Equity Fund seeks long-term total return (that is capital gain and yield). The Portfolio seeks to achieve this objective by investing predominantly in a diversified portfolio of European-domiciled companies that enjoy earnings and cash flow growth that are greater than the average earnings and cash flow growth of constituents of the MSCI Europe Index.
