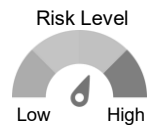

**INVESTMENT OBJECTIVE AND SUMMARY**

The Fund intends to achieve liquidity and stable income derived from a diversified portfolio of primarily short-term fixed income instruments. The Fund aims to provide returns in excess of the return of the 91-day Philippine Treasury Bill.

KEY RISKS AND RISK MANAGEMENT

Interest Rate Risk: Investors are exposed to adverse changes in the prices of domestic fixed income securities due to a rise in interest rates, which generally causes fixed income security prices to decline. Factors/ events that may lead to a rise in interest rates include adverse market conditions, issuer-specific factors / events and/or negative developments in domestic political and economic conditions.

Liquidity Risk: Possibility to experience losses due to the fund's inability to convert assets into cash immediately or in instances where conversion to cash is possible but at a highly disadvantageous price.

Credit/Default Risk: Investors are exposed to the risk of loss due to the failure of the borrower/ debt issuer to make timely interest and/ or principal payments on its deposit liabilities, loans, bonds or other debt instruments due to a deterioration in the borrower's/ issuer's financial condition or external factors and events that may affect its ability to repay financial obligations such as negative developments in domestic political and economic conditions.

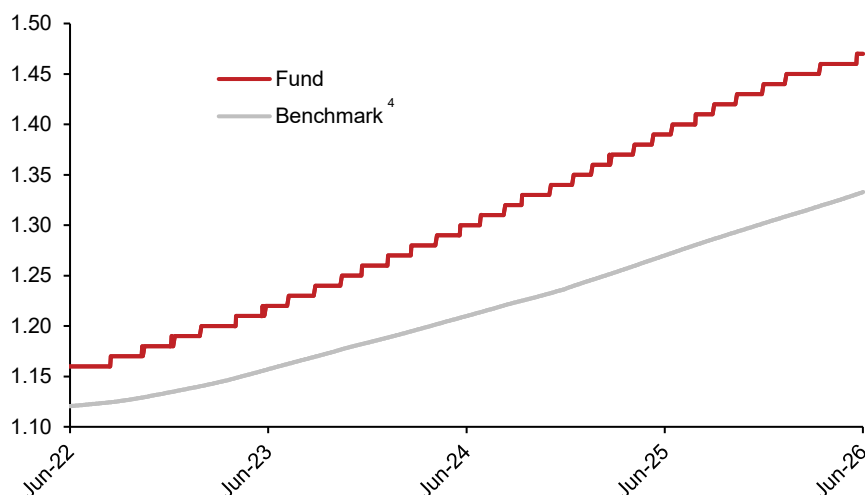

Description and Key Characteristics: Treasury Bills are zero coupon peso-denominated short-term fixed income securities issued by the Republic of the Philippines through its Bureau of Treasury.

Relation to the Fund's Objective or Investment Strategy: The Fund is actively managed, allowing the Trustee full discretion on security selection. Given the Fund's primary objective of capital preservation for investors with a short-term horizon, the 91-day Treasury Bill, a liquid security that is representative of attainable short-term placements, is an appropriate benchmark. Investors may use the benchmark to gauge the Fund's performance.

OUTLOOK AND STRATEGY

Market Review. Short-dated yields were mixed in June, with the very front end of the curve moving higher while yields across the rest of the curve generally declined. Month-on-month, the 1-month, 3-month, and 6-month BVAL increased by 35 bps, 19 bps, and 21 bps, respectively, while the 1-year BVAL decreased by 16 bps. Yields from the 2-year to 20-year tenors fell by an average of 58 bps, reflecting improving inflation expectations and a more constructive outlook for interest rates. During the June 29 Treasury bill auction, investor demand remained broadly stable, with total tenders reaching PHP 122.61 billion against a PHP 60.00 billion offering, equivalent to an overall bid-to-cover ratio of 2.04x. Demand was strongest in the 364-day tenor, which attracted PHP 43.92 billion in bids and recorded a bid-to-cover ratio of 2.20x, followed by the 182-day tenor at 2.10x. Auction results settled at 5.245% for the 91-day bill, 5.764% for the 182-day bill, and 5.968% for the 364-day bill. Relative to the previous auction, awarded yields increased modestly at the shorter tenors but declined by 7 bps for the 364-day bill, suggesting continued investor interest in longer-dated Treasury bills. Sentiment remained supported by easing inflation concerns and a more favorable medium-term interest rate outlook. While investors continued to maintain liquidity through shorter-dated placements, demand for longer-dated Treasury bills remained firm as market participants looked beyond near-term inflation pressures.

Fund Performance. The Fund returned 0.68% during the month of June, outperforming the benchmark by 25 basis points.

Fund Strategy. The Fund continues to maintain a nimble portfolio position to capture opportunities as interest rates are expected to remain elevated in the near term. Local inflation remained above the BSP's target range, with April data showing continued price pressures driven largely by higher food and energy costs and their indirect impact on other goods and services. This environment may support the BSP's cautious stance, with monetary policy expected to remain tight over the coming months.

Market volatility may persist in the near term, influenced by global developments and evolving domestic inflation dynamics, and the Fund will be actively managed to navigate these conditions. Investors should note that bond funds may experience short-term price fluctuations, and returns are generally realized over a medium- to long-term investment horizon.

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- (a) Primarily short term tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP; marketable instruments that are traded in an organized exchange; investment outlets/ categories the BSP allow. Provided, that, a financial instrument is regarded as tradable if quoted two-way prices are readily available and regularly available from an exchange, dealer, broker, industry group, pricing service or regulatory agency, and those prices represent actual and regularly occurring market transactions on an arm's length basis;
- (b) Primarily short term tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund or any such instrument as may be allowed under BSP regulations. Investment with related interests shall be in accordance with Section 414-Q of the MORNBF1;
- (c) Deposit products;
- (d) Such other investments suitable to the nature, classification, and strategy of the Fund, as allowed by prevailing regulations.
