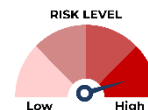

**INVESTMENT OBJECTIVE AND SUMMARY**

The Fund, operating as a Fund-of-Funds, seeks to achieve long-term capital growth by investing in a diversified portfolio of global equity and fixed income collective investment schemes which integrate environmental, social, and governance criteria in its investment process, including the incorporation of sustainability goals and facilitation of flow of funds towards green economic activities, climate change mitigation and adaptation projects, and other positive environmental and social impact initiatives.

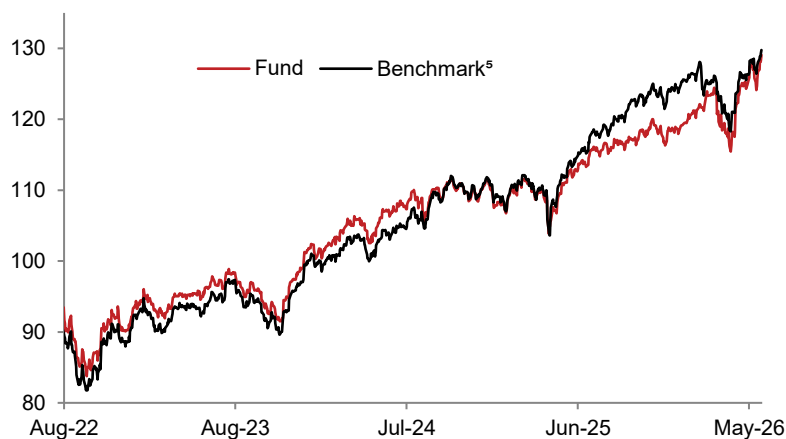

<b>MSCI All Country World Index Net Total Return USD Index</b>	The MSCI ACWI Index, MSCI's flagship global equity index, is designed to represent performance for the full opportunity set of large- and mid-cap stocks across 23 developed and 24 Emerging Markets. With 2,757 constituents, the index covers approximately 85% of the global investable equity opportunity set. The index is based on the MSCI Global Investable Market Indexes (GIMI) Methodology – a comprehensive and consistent approach to index construction that allows for meaningful global views and cross regional comparisons across all market capitalization size, sector and style segments and combinations. This methodology aims to provide exhaustive coverage of the relevant investment opportunity set with a strong emphasis on index liquidity, investability and replicability. The MSCI Total Return Indices measure the market performance, including price performance and income from regular cash distributions (cash dividend payments or capital repayments). MSCI's Daily Total Return (DTR) methodology reinvests regular cash distributions in indices on the ex-date of such distributions.
<b>Bloomberg Barclays Global Aggregate Bond Index (Unhedged)</b>	The Bloomberg Global Aggregate Index is a flagship measure of global investment grade debt from twenty-eight local currency markets. This multi-currency benchmark includes treasury, government-related, corporate and securitized fixed-rate bonds from both developed and emerging markets issuers. A component of the Multiverse Index, the Global Aggregate Index was created in 2000, with index history backfilled to January 1, 1990.

## OUTLOOK AND STRATEGY

**Market Review.** In May 2026, global fixed income markets were driven by a sharp rise in interest rates early in the month, followed by some stabilization, with the Bloomberg Global Aggregate Bond Index (unhedged USD) delivering a modest gain of 0.34% despite ongoing volatility. Government bonds declined initially as inflation concerns and elevated oil prices pushed yields higher, with 10-year U.S. Treasuries rising toward 4.6–4.7% and longer-dated yields moving above 5%. Markets stabilized later in the month as investors adjusted to the view that central banks are likely to keep interest rates higher for longer. Investment grade credit was relatively resilient, as strong corporate fundamentals and steady investor demand helped offset the impact of rising government bond yields. High yield outperformed, benefiting from attractive income and improving risk sentiment, with spreads tightening and generating positive returns even as government yields rose. Emerging market debt delivered mixed but generally stable performance. Rising U.S. rates weighed on dollar-denominated bonds, while a stronger U.S. dollar created headwinds for local currency debt. However, both segments were supported by relatively attractive yields and solid underlying fundamentals.

Global equities advanced strongly in May 2026, with the AI investment cycle once again the dominant driver as markets absorbed a mid-month inflation scare and sustained geopolitical uncertainty around the Iran conflict. The S&P 500 gained 5.3% over the period, notching its ninth consecutive weekly advance by month-end — the longest winning streak since 2023 — powered by blockbuster earnings and raised outlooks from AMD, Dell, and Micron, the latter surging to a \$1 trillion market cap in its best month since 1985. A mid-month bond selloff and oil spike briefly rattled risk assets, with emerging markets selling off sharply on May 15 on inflation and dollar-strength concerns, before markets recovered swiftly as ceasefire optimism re-emerged and the AI narrative reasserted itself. Leadership was concentrated in AI-linked semiconductors, with the breadth of the rally notably narrower than April's broad-based rebound. Regionally, Japan's Nikkei 225 led with an 11.9% gain, catching up to the global tech rally, while MSCI Asia Pacific surged 8.5% and MSCI Emerging Markets rose 9.7%, anchored by South Korea's Kospi — the world's top-performing benchmark year-to-date — driven by SK Hynix and the broader AI hardware supply chain. European equities lagged, with the Euro Stoxx 50 up 3.9%, as the region remained more sensitive to oil price swings than global peers.

**Fund Performance.** The fund returned 3.52%, outperforming the benchmark by 80 basis points. Security selection within the fund helped performance.

**Fund Strategy.** The Fund looks to maintain a nimble portfolio position to take advantage of any opportunities as global inflation is seen to increase over the next few months, partly driven by potential second-round effects from geopolitical tensions in the Middle East. Volatility may persist in the near term driven by global factors, and the portfolio will be actively managed to take advantage of this. Investors in the fund must be prepared to withstand volatility as higher investment value is normally achieved over the medium to long term horizon. As for Equities, the constructive stance on global equities is reinforced by May's price action, with earnings momentum and the AI capex cycle remaining the primary drivers. The tilt toward emerging markets and Asia continues to be supported by strong relative performance, though oil-driven inflation risks and bond market repricing remain live tail risks for the broader rally.

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

(a) Primarily in more than one collective investment scheme ("CIS") managed using a sustainable investment strategy aligned with sustainability metrics or frameworks such as the European Union Sustainable Finance Disclosure Regulation (SFDR), United Nations Sustainable Development Goals (SDG), and other globally recognized fund rating agencies or companies, that are approved or registered and supervised by regulatory authorities that is a member of the International Organization of Securities Commissions (IOSCO) and managed by reputable fund manager/s the investment objectives and policies of which are generally consistent with those of the Fund; provided further that such combined investment in collective investment schemes should not fall below ninety percent (90%) of the net asset value of the Fund. The Target Fund must be recognized as a collective investment scheme in its home jurisdiction by a regulatory authority or any regulatory authority acceptable to the BSP to supervise this CIS;

(b) Deposits products;

(c) Money market instruments;

(d) Short-term tradable fixed-income instruments issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund; and, any such other instruments as may be allowed under BSP regulations. Investment with related interests shall be in accordance with Section 414-Q of the MORNBF1;

(e) Such other investments suitable to the nature, classification, and strategy of the Fund, as allowed by prevailing regulations.

(f) The principal investments of the Fund will be denominated in, but not limited to, the following major currencies: U.S. Dollar, Euro, British Pound, Canadian Dollar, Australian Dollar, Swiss Franc, Danish Kroner, and Japanese Yen.

The performance of the underlying Target Fund/s on an individual or collective basis impacts the performance of the BPI Sustainable Global Balanced Fund-of-Funds.

The BPI Sustainable Global Balanced Fund-of-Funds incurs trust fee payable to the Trustee on top of the management fee/s charged by the Target Fund/s. Said fees and other expenses are already included in the computation of the Net Asset Value per Unit, which is the price at which investors subscribe and redeem units of the Fund.
