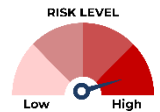

**INVESTMENT OBJECTIVE AND SUMMARY**

The Fund, operating as a fund-of-funds, seeks to achieve for its Participants long-term capital growth by investing in a diversified portfolio of global equity collective investment schemes which integrate environmental, social, and governance criteria in its investment process, including the incorporation of sustainability goals and facilitation of flow of funds towards green economic activities, climate change mitigation and adaptation projects, and other positive environmental and social impact initiatives. The Fund aims to outperform its benchmark which is the MSCI All Country World Index Net Total Return USD Index.

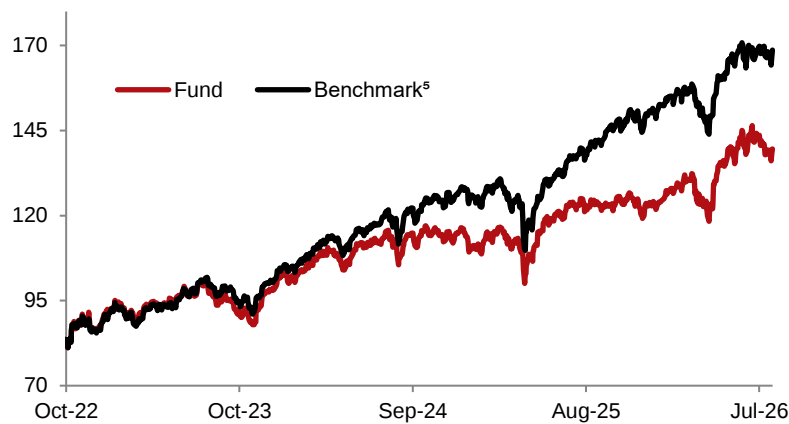

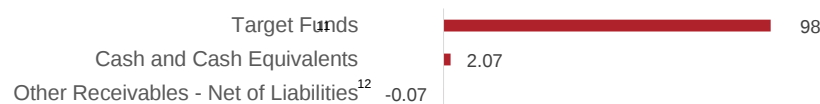

MSCI All Country World Index Net Total Return USD Index	The MSCI ACWI Index, MSCI's flagship global equity index, is designed to represent performance for the full opportunity set of large- and mid-cap stocks across 23 developed and 24 Emerging Markets. With 2,757 constituents, the index covers approximately 85% of the global investable equity opportunity set. The index is based on the MSCI Global Investable Market Indexes (GIMI) Methodology – a comprehensive and consistent approach to index construction that allows for meaningful global views and cross regional comparisons across all market capitalization size, sector and style segments and combinations. This methodology aims to provide exhaustive coverage of the relevant investment opportunity set with a strong emphasis on index liquidity, investability and replicability. The MSCI Total Return Indices measure the market performance, including price performance and income from regular cash distributions (cash dividend payments or capital repayments). MSCI's Daily Total Return (DTR) methodology reinvests regular cash distributions in indices on the ex-date of such distributions.

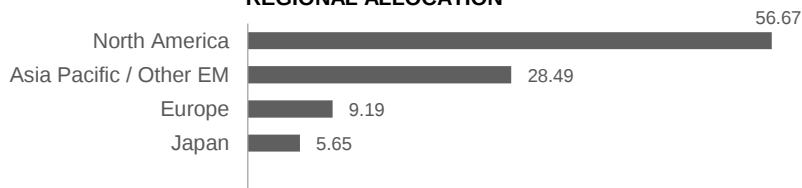

OUTLOOK AND STRATEGY

Market Review. Global equities posted modest gains in July, with the MSCI World Equity Index Total Return rising 0.42% MoM in PHP terms. Risk sentiment was weighed down by renewed US-Iran hostilities and fresh US tariffs imposed on multiple trading partners. Technology stocks also experienced heightened volatility as investors questioned the sustainability of elevated AI-related capital spending and reacted to competitive developments from Chinese AI startup Moonshot. Additionally, uncertainty surrounding monetary policy persisted after the US Federal Reserve kept interest rates unchanged at 3.50%-3.75%, with a divided vote highlighting differing views on policy direction. Nonetheless, markets recovered toward month-end, supported by strong corporate earnings from Microsoft and Amazon, which reinforced confidence in the long-term AI growth theme.

Fund Performance. The fund returned -3.25%, underperforming the benchmark by 333 basis points. Security selection within the fund helped performance.

Fund Strategy. We maintain a favorable outlook on global equities, driven by steady economic growth and an AI-fueled capital expenditure cycle that continues to lift corporate earnings worldwide. Although the fund preserves significant exposure to AI and its associated beneficiaries, we see compelling opportunities to diversify into lower-valued sectors displaying strong earnings momentum. However, persistent global monetary tightening and escalating Middle Eastern tensions, which threaten to push oil prices higher, remain primary risks to the broader market rally.

LIST OF PROSPECTIVE INVESTMENTS

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

a) Primarily in more than one collective investment scheme ("CIS") managed using a sustainable investment strategy aligned with sustainability metrics or frameworks such as the European Union Sustainable Finance Disclosure Regulation (SFDR), United Nations Sustainable Development Goals (SDG), and other globally recognized fund rating agencies or companies, that are approved or registered and supervised by regulatory authorities that is a member of the International Organization of Securities Commissions (IOSCO) and managed by reputable fund manager/s the investment objectives and policies of which are generally consistent with those of the Fund; provided further that such combined investment in collective investment schemes should not fall below ninety percent (90%) of the net asset value of the Fund. The Target Fund must be recognized as a collective investment scheme in its home jurisdiction by a regulatory authority or any regulatory authority acceptable to the BSP to supervise this CIS;

(b) Deposit products;

(c) Money market instruments;

(d) Short-term tradable fixed-income instruments issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund; and, any such other instruments as may be allowed under BSP regulations. Investment with related interests shall be in accordance with Section 414-Q of the MORNBF;I;

(e) Such other investments suitable to the nature, classification, and strategy of the Fund, as allowed by prevailing regulations;

(f) The principal investments of the Fund will be denominated in, but not limited to, the following major currencies: U.S. Dollar, Euro, British Pound, Canadian Dollar, Australian Dollar, Swiss Franc, Danish Kroner, and Japanese Yen.

Qualified Participants

Participation in the Fund shall be open to Participants with legal capacity to contract and who are not considered US persons under the US securities and tax laws, subject to the other conditions, rules or provisions stated in the Plan Rules and those established by the Trustee. No beneficial owner shall hold more than 10% of the Fund. Any investor who owns more than 10% shall be asked to redeem the amount (or its equivalent number of units) in excess of 10% within thirty (30) calendar days.

SPECIFIC RISKS IN INVESTING IN A FUND-OF-FUNDS

The performance of the underlying Target Fund/s on an individual or collective basis impacts the performance of the BPI Sustainable Global Equity Fund-of-Funds.

The BPI Sustainable Global Equity Fund-of-Funds incurs trust fee payable to the Trustee on top of the management fee/s charged by the Target Fund/s. Said fees and other expenses are already included in the computation of the Net Asset Value per Unit, which is the price at which investors subscribe and redeem units of the Fund.
