

Item 9 - Other Events

The Board of Directors of the Bank of the Philippine Islands ("BPI") approved on 15 March 2023 the declaration of property dividends consisting of 406,179,276 BPI common shares held in treasury (the "Property Dividend") to be distributed to all eligible stockholders of BPI as of record date of 29 March 2023 (the "Record Date," and the eligible stockholders, the "Stockholders") at an entitlement ratio of 0.0896395563 common share for every one (1) common share of BPI held by the Stockholder. The payment of the Property Dividend was carried out on 16 June 2023 (the "Payment Date"), following BPI's receipt of the Certificate of Filing the Notice of Property Dividend Declaration issued by the Securities and Exchange Commission last 13 June 2023. The Cross Price for the transfer of the Property Dividend through the Exchange is Php105.00 per share. The Property Dividend shares was recorded in the name of PCD Nominee Corp. for the account of the Stockholders in the books of BPI on Payment Date. Following such payment, the total outstanding shares of BPI changed from 4,539,018,015 to 4,945,197,291 common shares as of 16 June 2023.

The actual distribution of the Property Dividend to the Stockholders shall be in accordance with the Property Dividend Guidelines, as amended and supplemented, which was previously disclosed by BPI.

Pursuant to the requirement of the Securities Regulation Code, the registrant has duly caused this report to be signed on its behalf by the undersigned hereunto duly authorized.
