Bank of the Philippine Islands ("BPI" or the "Issuer") has mandated BPI Capital Corporation as Sole Global Coordinator alongside BofA Securities, HSBC, J.P. Morgan and UBS¹, as Joint Bookrunners to arrange a series of fixed income investor meetings commencing on 26 March 2025. A U.S. dollar-denominated benchmark-sized Regulation S offering of 5-year FXD and/or FRN and/or 10-year FXD senior notes (the "Notes") may follow, subject to market conditions. The Notes are expected to be rated BBB+ by S&P, and when issued, will constitute a drawdown under BPI's US\$3,000,000,000 Medium Term Note Programme.

The legal adviser of the Issuer as to Philippine law is SyCip Salazar Hernandez & Gatmaitan, and the legal adviser of the Joint Bookrunners as to Philippine law is Romulo Mabanta Buenaventura Sayoc & de los Angeles. 


